



Dear Supplier,

In the food industry, proper temperature management is a critical element in maintaining quality and ensuring food safety. Maintaining the “cold chain” can best be monitored during shipments through the utilization of temperature recorders. Due to the complexity of running numerous proprietary software programs on our computers to download each individual temperature recorder at our Distribution Centers, we are requesting that you utilize only the **electronic** temperature recorders indicated in the following list. These **electronic** temperature recorders will be required on each pre-cooled shipment of **produce, floral, meat, poultry, and seafood** in-bound to our food distribution centers, food import centers, and food cross docks.

Walmart is further requiring that the temperature recorder: (1) be placed above the “load line” on the **left** side of the trailer, **and out of the direct path** of the discharge from the refrigeration unit, (2) “**Recorder on Pallet**” sticker applied to face of pallet (**This is a Walmart REQUIREMENT; stickers are available through the recorder suppliers**) indicating recorder has been placed on top of the pallet. The temperature recorder number and brand name **must** be indicated on the appropriate Bill of Lading.

Your cooperation is very much appreciated.
